

Commissioners and Planners, [This is the same email that I have been sending for all of the winery projects coming before you at the Soda Canyon Road Junction. Although the issue of continued, and I think unfortunate, building development along the Trail is an important one, this email is just for the record on the Grassi project and you needn't re-read it.] The Silverado Trail is still a great ride for cars and bicycles at times other than the afternoon rush hour. Well banked curves and maintained surface allow a meditative, almost zen-like, cruise through the rolling landscape of vine rows and valley vistas. It is the ride that defines the Napa Valley as an Eden, a paradise on earth, for visitors and residents alike. It is a last local vestige of America's great passion for the open road. And it is about to disappear. Two more wineries on or adjacent to the Trail are up before the Planning Commission on Jan. 18th and Feb 1st, 2017, the Sam Jasper Winery and the Grassi Winery. The requests for production capacity and visitation are modest, but the applications do call attention once again to the issue of continued development on this most iconic of Napa's highways.

This particular section of the Trail is becoming quite impacted by building projects. It is a harbinger of the development sprawl happening along the Trail and throughout the county. As shown here, there are now close to 100 new or expanding wineries approved since 2010, most not yet built. There are some 50 more in the planning department awaiting review, with 18 more added in 2016 alone. I can understand the Commission's unfortunate need for additional hearings each month. This is a map of the Soda Canyon intersection. There are now at least 8 existing or proposed left turn lumps on the Trail in the 1.5 minute drive between Hardman Avenue and Black Stallion Winery. Little will remain of the 2-lane highway. It will now be a section fraught with the driving angst of merging traffic. Will all of these turnouts make it safer? Maybe for those forced to become familiar with the concept of middle lane refuges. For most drivers there will still be the heart attack

(and involuntary swerve), as a car dashes out from the left straight at their car and at the last second turns into the refuge lane. The number of vehicle trips generated by the proposed wineries is adding up. Counting Mountain Peak which has just been approved, there are now almost 380 more trips/day planned of this bit of the Trail. That's about 3% of the 11,000 [now 14000?] daily vehicles that use the intersection. It is well above the 1% increase considered "significant" for any one project. Impacts accumulate. Soda Canyon Road is already rated at Level of Service (LOS) F on weekday and Saturday afternoons and traffic signals are already warranted on weekday afternoons. They will shortly be needed on Saturdays as well. It is harrowing to make the left turn into the continuous stream of 55 mph traffic at rush hour. The traffic backs up behind the Soda Canyon stop sign waiting for one's rendezvous with fate. The Soda Canyon intersection, like many intersections along the Trail and Hwy 29 already requires signalization for safe operation. As you know, the cost of those signals are often contributed to by mitigation fees added to the use permits. The signals don't get put in, I think, not just because the mitigation fees aren't enough to cover the costs (and the money is needed elsewhere), but because everyone knows what signalization means - a rural place is becoming a suburb. It is the death of the open road. This map begins to give a sense of the winery strip mall that the rest of the Trail will become in the future. There are still several parcels in this stretch available for wineries. Given the present trajectory, projects will be proposed soon. (The property just north of the Reynolds Winery has recently sold.) Is it too late to save the Silverado Trail? The openness of the landscape along its route defines Napa County to residents as well as the rest of the world. As the area around Soda Canyon Road shows, that iconic image will become screened and diminished by development if more protections are not put in place. It is past time to realize that the Trail is more important to Napa than just an access route to ever more wineries or just traffic relief from Hwy 29. The expansive views from the road are the mental images that everyone retains of this place. It is a single Napa experience more important than all the winery "experiences" combined. If the present development trend continues, the enjoyment of the Trail as the meditative cruise needed to be at one with the rolling majesty of the valley and its bounty will soon be gone. We are writing regarding the proposed Grassi Wine Company winery at 1044 Soda Canyon Road, Napa CA. The proposal is for a small capacity winery located on existing vineyard property and proposing 25,000 gallons and 3,800 visitors per year and 20 vehicle trips per day. We believe the Grassi proposal is in keeping with the culture and environmental limits of the Soda Canyon area. As homeowners on Soda Canyon Road, we welcome this new business and appreciate its thoughtful design and appropriateness for the site.

Keeping that in mind, there are also issues of cumulative impacts that are part of the baggage of Napa County approving the majority of winery proposals that come before it. The Grassi proposal is modest in scope and far less impacting regarding traffic issues. The cumulative impact of more visitors, more noise and more night-time events is already taxing the carrying capacity of the road, people and environment of Soda Canyon.

If the County had the vision to encourage small capacity wineries in these areas while locating the large commercial operations in industrial parks more suited to their impacts, the public could begin to trust their county managers and elected officials again.

# STATEMENT OF YEORYIOS C. APALLAS BEFORE THE NAPA COUNTY PLANNING COMMISSION IN THE MATTER OF GRASSI FAMILY WINERY P15-00339-UP WEDNESDAY, FEBRUARY 1, 2017 AT 9:00 A.M.

- 1. My name is Yeoryios C. Apallas. I live at 4054 Silverado Trail, Napa, California. I am a lawyer, and from 1972 to 1999, I served as a deputy attorney general in the California Department of Justice. In early 1999 I had a dual appointment as Senior Assistant Attorney General and Special Counsel to the Governor's Office. In late 2000 I became the general counsel for S & P Company, its wholly owned subsidiaries, Pabst Brewing Company, and Falstaff Brewing Corporation and the umbrella organization—the Kalmanovitz Charitable Foundation, a nonprofit corporation with assets over half a billion dollars. I retired from this position in December 2013 now serve on various boards including the Board of Directors of the Napa County Farm Bureau. See, attached profile.
- 2. My family owns property at 4050, 4054 and 4060 Silverado Trail, (ST Property) and also at 1005, 1035, and 1045 Soda Canyon Road "(SCR Property"). The ST and SCR property has been in the Johnston Family (my parents-in-law) since November 30, 1944.
- 3. The SCR Property is on the northwestern side of Soda Canyon Road and directly across from: (a) the proposed Grassi Winer and (b) approximately 500 feet east from where Soda Canyon Road intersects with the Silverado Trail.
- 4. The ST Property is a twenty (20) acre parcel which, in 2006, we developed into a vineyard known as Soda Creek Vineyards. My wife, my children and my grandsons, my wife and I call this our home. It is located approximately 700 feet from the intersection of Soda Canyon Road and the Silverado Trail and about 1000 feet from the proposed winery, as the crow flies. My wife and I are the proprietors and operators of this family owned vineyard. We live on the property with our son, his wife, and 2 young grandchildren, Yeoryios, 2 years old and Leonidas, 4 months old. So you can understand how important safety is to us on both SCR and ST.
- 5. I am not opposed to reasonable and prudent vineyard development nor am I opposed to the manufacture of wine at appropriate, safe, and environmentally suitable sites. My statement should not be construed as opposing the crafting of wine at the proposed Grassi Winery facility. My concern about the citing of this project at this location is that it will add more traffic at the intersection of Soda Canyon Road and the Silverado Trail.
- 6. Because of the narrow and serpentine nature of Soda Canyon Road and more particularly where the 1035 and 1045 SCR Properties are located, there have been numerous accidents, (most unreported to the California Highway Patrol (CHP)) and the Napa County Sheriff's Office (NCSO) with cars crashing into the front yards of these properties causing substantial property damage. Just two years ago (July 8, 2015) while I

was taking the attached photos, cars going east and west on SCR were crossing the double yellow line at the curve depicted on Photograph No. 5.

- 7. I recall that in the Summer of 2000 a driver, traveling down SCR, lost control of his Jaguar and crashed into the 1035 SCR Property causing damage to the auto, the fence, and the mailbox but leaving at the scene of the accident the Jaguar's rear license plate. The driver fled, but did not get too far because of a punctured oil pan and the rear license plate at the scene.
- 8. Around June 15, 2008 there was another accident which took out the electrical service to the residence at 1035 SCR. This accident was reported to the CHP. Like the one before it, this too was a single driver accident where the driver lost control of the vehicle coming around the curve and crashed into the PGE pole knocking down the electrical wires to the service box of my parents'-in-law home. The driver rolled his car but managed to flee the scene but was later apprehended.
- 9. Evidence left at the scene suggests that both accidents were caused by alcohol consumption and excessive speed at a curve that is dangerously configured. The county tried to address the many accidents that occurred at that location by smoothing out the curve and reducing the speed to 30 miles per hour but accidents continue to happen at this location. Just six months ago on Friday, July 8, 2016 at 4:15 p.m., I was paying a social visit to my sister in law at 1035 Soda Canyon Road, and was almost broadsided by someone speeding down Soda Canyon Road in a truck. I gunned my little Prius Electric and quickly got out of the speeding driver's way.
- 10. A grant of a use permit to Grassi Winery (as outlined in its recently filed application) will only compound the dangerous road condition and will, in all probability, increase the accident rate at 1035 and 1045 SCR because of the curve on the road and the potential for driving under the influence of alcohol. Increased traffic on the road will, in all likelihood, add to the possibility of additional accidents at or around the SCR Properties. Over the years of development up SCR, I have observed a marked increase in traffic on this two lane narrow country road. The traffic on Silverado Trail, as recently noted in the Sam Jasper review, highlighted that some 14,000 trips per day are on the Trail between Trancas and Oak Knoll. Just 8 years ago, there were only around 4500 daily trips on the same stretch of the ST. The traffic has increased 300% during this period. Annualized the yearly trips on Silverado Trail are in excess of 5 million. Imagine what it will be like if the wineries that are yet to be built, actually are built and become operational. Incredible.
- 11. Already, during the rush hour at between 4:00 to 5:00 p.m., it is difficult to back out of the driveway at 1035 SCR because cars are backed up that are trying to make a left or right turn onto Silverado Trail. At times, when trying to leave the property, I have to wait several minutes until traffic clears up to safely exit. At other times, I alter my plans and either wait until after the traffic abates at the driveway area so that I can continue with my travel plans, or abandon my plans altogether and reschedule them at a more suitable time. The Grassi Winery tourism and tastings will only make matters worse.

- 12. To dramatically illustrate this point, on the afternoon of Monday, July 13, 2015, I went out to the intersection of SCR and ST to count westbound cars. At 4.02 p.m. I started counting cars that were traveling west on SCR (coming downhill). Between 4:02 p.m. and 5:02 p.m., I counted 131 cars. An additional 36 cars came down the road at between 5:02 p.m. and 5:32 p.m. A total of 166 cars came down the SCR between the hours of 4:02 p.m. and 5:32 p.m.
- 13. The County of Napa has rated the SCR and ST intersection at <u>Level of Service</u> (<u>LOS</u>) <u>F</u> which is defined as a level of service marked by "stop and go" traffic and stoppages of long duration and vehicles at signalized intersections usually have to wait through one or more changes, and intersections may be blocked by the long queues. (See, <u>Napa County General Plan, Circulation Element, Page CIR-15</u>, dated June 3, 2008.
- 14. While counting cars at this intersection, I witnessed an "almost accident" as an impatient driver made an abrupt left turn onto southbound Silverado Trail from Soda Canyon Road, and was within feet of getting wiped out by a truck traveling northbound on Silverado Trail.
- 15. Again, if the use permit is issued to Grassi Winery based on its current application, it will only create more backups at the 1035 SCR Property and create safety problems for all residents at the vicinity of these properties. There are a number of vineyards and wineries up the SCR canyon and county traffic studies that I have reviewed do indicate that the traffic at the intersection of SCR and ST, will only get worse.
- 16. Additional planned wineries within a quarter mile of the intersection of SCR and the Silverado Trail will only worsen the traffic conditions at that intersection. The Corona Winery which has not yet been built but approved will add an additional 16,988 trips per year. Sam Jasper Winery at 4059 Silverado Trail will add another 8,870 tourist vehicle trips. The Beau Vigne at 4057 Silverado Trail will contribute 5,820 trips per year (see, Attachment No. 1). The Grassi Winery at 1060 Soda Canyon Road will increase traffic by 3,795 trips per year. And finally, the Reynolds Winery at 3266 Silverado Trail will add in excess of 15,178 vehicle trips a year. If all these wineries come on line in the next two years as planned, including Mountain Peak Winery, the total additional vehicle trips will exceed 111,149 vehicle trips per year or an increase of 120%. There is little doubt that this additional traffic when added to the tourist traffic from all these wineries, will degrade the traffic flow at SCR and the Silverado Trail and impact the quality of life of the residents surrounding the Grassi Winery and the SCR/Silverado Trail intersection. Already Napa, in 2013, ranked as the second worst traffic venue in all 58 California counties as it relates to total fatal accidents and injuries. And Napa is the 7<sup>th</sup> worst in California in 2013 when it comes to alcohol involved incidents.
- 17. Finally, it bears mentioning that information obtained from the <u>Department of California Highway Patrol</u>, <u>Data Warehouse</u>, <u>Incident Details Reports</u>, from January 1, 2013 to April 11, 2016 highlights 36 incident reports at or near Soda Canyon Road. *See, Attachment 2*. Here is the list of incidents that are material:

Semi-Trucks Stalls/Accidents: 2

Unidentified: 1

Daytime Incidents (7am-6pm): 22 Nighttime Incidents (6pm-6am): 14

- 18. In just over 3 years, the above described 36 incidents took place either on Soda Canyon Road or at the intersection of Silverado Trail and Soda Canyon Road. Of particular note are the 18 total one and two car collisions, the 3 reports of reckless driving, the 2 semi-truck related incidents, and most importantly, the 7 driving under the influence reports. Incident number 140910GG01108 is also worthy of special attention because on September 9, 2014 at the height of the 2014 harvest season, it involved a semi-truck that overturned on the steepest part of the hill (around mile 4.5 of Soda Canyon road below the proposed Mountain Peak Winery site) and blocked ALL ingress and egress to every property above that point for more than 5 hours and two tow trucks to remove it. Had that truck started a wildfire, which can and does happen, or had there been an emergency incident above that location, ALL persons above that point would have been trapped. Again, this is just a sampling because it does not include the Sheriff's reports for Soda Canyon Road during the same period, but it certainly provides some insight as the type of accidents that regularly occur on or near Soda Canyon Road.
- 19. It is also worth mentioning that (on information and belief) Mr. and Mrs. Grassi have and may be continuing jazzercise and yoga classes on the subject property. This is not a permitted use in the AP zoning. I strongly recommend that if the PU permit is granted that it contain an additional condition to the effect that "no other commercial activities are permitted on the Grassi property other than those permitted activities as expressed in the conditions approved by the PC".

I declare under penalty of perjury under the laws of the State of California that the above is true and correct except as to those matters that are stated on information and belief and

Large semi truck on its side, white cab, single trailer, blocking the middle of the road, roadway is completely blocked, unable to get traffic by. Rear axel [sic] completely separated from the truck. Driver left vehicle, found at 2600 Soda Canyon Road on side of roadway with other people, has a broken shoulder. CalFire requested, heavy tow. Roadway may be blocked few hours. Soda Canyon Road 2 miles north of Soda Springs Road closed due to collision. First tow truck now hanging over cliff; trying to recover their own truck. Second tow company (Ramirez Tow) doing recovery on vehicle."

**Director's name:** YEORYIOS C. APALLAS

Current professional information and information about Director's role with NCFB (interests, committees, volunteerism, events, etc.): Yeoryios has practiced law since 1972 and remains active in legal matters. He specializes in business and fiduciary litigation. During his 44-year career, Yeoryios served as a senior assistant attorney general, as special counsel to the Office of the Governor, and as a vice president and general counsel for Pabst Brewing Company and its related breweries. He continues to serve as a director to nonprofit and for-profit organizations. As an NCFB board member, he plans to use his special skills in corporate governance, land use planning, and nonprofit fiduciary standards as needed to serve the NCFB board and membership.

He participates, on an as-needed basis, in a number of nonprofit organizations that are focused on preserving the vitality of Napa's robust and diverse agricultural community. He is a member of the Napa Valley Grapegrowers and serves as a new board member to the Napa County Farm Bureau. He has served as a board member to the UC Davis Law School Alumni Association, as chief counsel to S & P Company, a real estate investment company, as a Senior Assistant Attorney General to the California Department of Justice, as Special Counsel to Governor Gray Davis and as counsel to the Kalmanovitz Charitable Foundation. Previous experience includes service as a director of Eton Corporation, chairman of the Novato Planning Commission, and a director of the Marin County Federation of Homeowners' Associations.

Director's educational background, including degrees: Yeoryios received his B.A. degree from Pomona College in Claremont, California, and his Juris Doctorate degree from UC Davis (King Hall) School of Law. He loves to tell the story of how he, through his entrepreneurial spirit, had earned more money than his mother and father, combined. But that was not hard to do. His parents earned a total of just two dollars per day. Optimism, street smarts, and hard work helped Yeorvios to realize the American Dream. Now, Yeoryios' life has taken him in a circle-from a young Greek boy who helped grow, harvest, and make wine in his village, to a senior citizen in the Napa Valley who still grows, harvests, and makes wine for personal consumption. The rest of the crop he sells to Napa Valley wineries.

Yeoryios lives on the Silverado Trail with his wife, his two sons, his daughter-in-law, and one grandson. His oldest child, a daughter, lives in Carlsbad, California, with her husband.

Yeoryios and his wife Nancy love to travel the world. They have visited numerous countries together, including Greece (of course), the Greek islands, Turkey, Italy, Spain, France, Germany, Switzerland, New Zealand, China, Russia, and Finland. God and health willing, they intend to continue their peripatetic life.


