Your Guide to Waste Management and Resource Recovery in the upper Napa Valley

Calistoga Elementary School Fourth Graders, Calistoga's Youngest Recycling Experts

Students in Marisa Henrichs' fourth grade class at Calistoga Elementary School turned a lesson in writing persuasive letters into a tremendous improvement in recycling for their entire school district.

"We should all know how to recycle in order to reuse our resources on our planet and lower the amount of new materials needed to meet our needs," wrote student Isai Carrillo in a letter to Calistoga Mayor Chris Canning. "Recycling programs teach students to recycle."

Students choose recycling as the topic for their assignment of writing persuasive letters. In February Mayor Canning received 21 letters from the students in Henrichs' classroom. The letters detailing the need for an improved recycling program caught Mayor Canning's attention. Mayor Canning is a board member on the Upper Valley Waste Management Agency (UVWMA). UVWMA provides coordination of economical, regional waste management services for the

upper Napa Valley.

"We use a lot of paper here at CES that is just thrown away," wrote student Kennia Clavel in her letter to Mayor Canning. "Recycling paper keeps our trees and forest

safe. We save 17 trees every time we recycle 2,000 pounds of paper." UVWMA staff connected with the school and taught the fourth graders how to be on-campus recycling experts, going beyond paper recycling

to more complicated items often found in classrooms and students lunches.

As new recycling experts, the students put together a skit they performed at a school assembly so all students at the school knew exactly what could and could not be recycled. With funding from CalRecycle, UVWMA provided Calistoga School District with both indoor and outdoor recycling bins, to capture recyclables throughout both the elementary and junior/senior high schools.

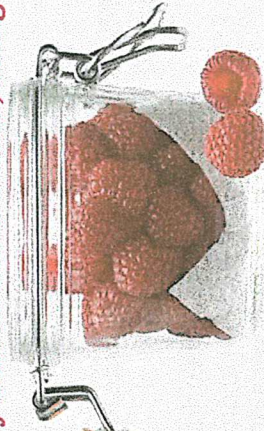

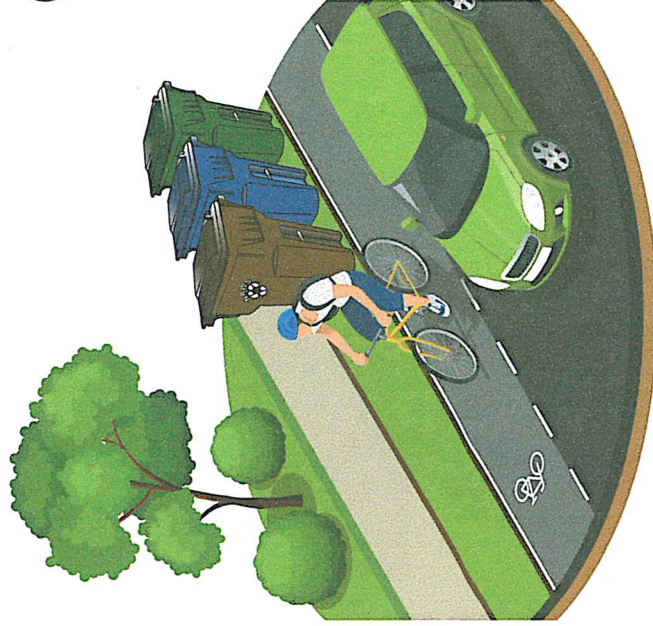

Cart Collection Reminders

- ✓ Carts should not obstruct bike lanes or sidewalks. Customers on the Silverado Trail should place carts closest to their driveway, to allow space for bicycles in the bike lane.
- ✓ Place at least 2 feet away from other carts and 4 – 6 feet from other objects (e.g. cars, trees).
- ✓ All items must be placed in the cart the night before your service day.
- ✓ Be sure lids fully close.
- ✓ Lid handle should be closest to curb.

Rate Adjustment: Though not completed at the time this newsletter went to print, the Upper Valley Waste Management Agency (the governing Board that oversees the Franchise Agreements with UVDS and Clover Flat Landfill) is in the process of reviewing revenues and expenses associated with hauling and landfill services. At the Landfill, the Board is expected to enact an approximate 3% increase, based primarily on the consumer price index (CPI). On the waste collection (UVDS) fee, the Board is considering a likely rate increase of around 1%. 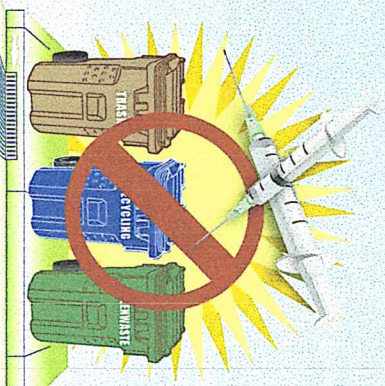
