### DETAILS OF ACCIDENT/INJURY

<b><u>Accident/Injury:</u></b> Organics fire in the Green Waste, Wood Waste, Food Waste & slope of well field
<p><b><u>How Accident/Injury occurred with details of event:</u></b></p> <p>Suspected that fire originated in a pile of ground green waste. Approx. 2 acres of ground green waste, wood waste and food waste burned. Location is lower pad near Module 5A. Vermeer grinder was burned and believed to be a complete loss.</p> <p>Loss of piping &amp; header piping on approx. four methane wells. Wells shut down and Jenbacher engine shut down until wells are repaired. Notified Golder Assoc. to notify BAAQMD of the wells that are shut down (for compliance).</p>
<p><b><u>Witnesses:</u></b></p> <p>Garry Lowe was notified by the fire department at approx. 3:00 am on 9/1/17. Material stock piles were completely involved and the Vermeer grinder was burned.</p> <p>Joe Magana, Jose Gutierrez, Shane Kohler and Fernando Manriquez responded shortly after Garry got on site and contacted them.</p>
