HAZARDOUS WASTE EVENT

Saturday October 26, 9AM-3PM
Napa County Fairgrounds in Calistoga

Upper Valley Waste Management Agency will host a one-day hazardous waste collection at the Napa County Fairgrounds located at 1435 N. Oak Street in Calistoga on Saturday, October 26, from 9 am to 3 pm. A licensed hazardous waste handling company will accept a variety of hazardous wastes from local residents at no charge.

To be safe, residents should pack hazardous waste in the trunk or bed of their vehicle and transport it in amounts less than 15 gallons or 125 pounds per trip. The event is open to all up-valley residents who receive waste collection services or use Clover Flat Landfill, but is for households only.

Businesses that generate limited quantities of hazardous wastes will be able to dispose of them on

Friday, October 25 from 1 pm to 4 pm. This collection event is open to only those businesses that generate less than 27 gallons or 220 pounds of hazardous waste per month. Appointments are required – call 707-259-8330 by 5 pm on Wednesday, October 23 to schedule a drop-off time. Businesses must pay disposal fees for hazardous wastes that they bring to this collection event.

How To Prepare Containers

Triple Rinse & Dry

Cut Down Larger Containers

- 5 Gallon: Cut in Half
- 15 Gallon: Cut in Thirds
- 30 Gallon: Cut in Thirds
- 50 Gallon Cut in Fourths

Remove

- Labels
- Metal Handles
- Caps
- Plastic Sleeves

Break down all cardboard boxes **before** arriving at the event

Commercial Recycling — EASY, Good for Business... and It's the Law!

The state of California currently requires all businesses and agencies that generate four or more cubic yards of waste per week to recycle. If your business or agency receives recycling pick-up service or can show it otherwise recycles, you meet this important requirement of state law. You are helping to reduce energy use, cut greenhouse gases and may even be saving money on your trash service bill. But that's not all...

To keep organic material out of landfills, the state requires businesses that generate food scraps, landscape trimmings, clean wood or grape pomace ensure these organic materials are composted.

Businesses are required to recycle their organic waste depending on the amount of waste they generate per week. As of January 1, 2019 businesses that generate 4 cubic yards or more of waste per week should arrange for composting services.

This statewide effort to compost organic materials instead of landfilling is critical to California achieving its aggressive recycling and greenhouse gas (GHG) reduction goals. More than 30 percent of waste currently landfilled in California can be composted to make soil or mulch. Dumping compostable materials in landfills creates harmful gases that contribute to global climate change. By composting, you can help California reach the goal of at least 75% recycling by 2020.
