WHEREAS, for purposes of redundancy and succession planning, the Board desires to add the General Manager and the Technical Services Director to the list of designated authorized agents regarding this Installment Sale Agreement.

NOW, THEREFORE, LET IT BE RESOLVED that the Board of Directors, as the governing body of the Napa Sanitation District (the "Entity"), does hereby designate and authorize the General Manager, the Director of Administrative Services, and the Technical Services Director to be "Authorized Representatives" of the District, conferring to each individually the authority of "Authorized Representative" as defined under the SWRCB Installment Sale Agreement No. SWRCB000000000D190101600.

Any of the Authorized Representatives is designated to represent the Entity in carrying out the Entity's responsibilities under the Installment Sale Agreement, including certifying disbursement requests on behalf of the Entity and compliance with applicable state and federal laws.
