Whereas, Task Order No. 04 was executed by District on March 27, 2018, to provide Professional Services. The authorized Not-to-Exceed fee for providing the services set forth in Task Order No. 04 was \$888,723; and

Whereas, Amendment No. 01 to Task Order No. 04 in the amount of \$62,650.00 was executed on July 23, 2019 to provide Additional Design Review. The authorized total Not-to-Exceed fee for Task Order No. 04 and Amendment No. 01 increased to \$951,373.00; and

Whereas, it is necessary to Amend said Task Order to provide for additional professional services not included in the original Task Order, as set forth below:

All terms and conditions of the original underlying Agreement, Task Order No. 04 thereto, shall remain in effect, except to increase the amount the Consultant may be paid by \$39,830.00, to a new Not-to-Exceed total amount of \$991,203.00.

SCOPE OF WORK

This Detailed Project Scope is to provide additional engineering services for the Napa Sanitation District West Napa Pump Station Rehabilitation Project. This Task Order will include some additional detailed design for the West Napa Pump Station and additional coordination with the BVT engineer, preparing the Caltrans application for the WNPS Contractor encroachment permit as well as time extension for project management due to the delay in project funding. Services to be provided by Hazen under this amendment for the final design services include the following tasks as delineated below and expanded in greater detail in the subsequent paragraphs:

- Task No. 5 – Final Design Documents
- Task No. 9 – Project Management
- Task No. 10 – Caltrans Encroachment Permit Application Preparation

Task 5 FINAL DESIGN DOCUMENTS

Under this amendment, Hazen shall provide additional Final Design task effort due to the time extension and additional coordination with the District and the BVT Engineer as listed below.

Subtask 5.1 Final Drawings and Specs

Based on comments coordination with the District and the BVT Engineer, Hazen shall revise the Design Documents to incorporate additional coordination items that include.

- Revised staging and site plans based on access for both projects.
- Revised sequencing based on coordination between the BVT and WNPS projects.
- Revisions to the front-end specifications.

Task 5 Deliverables

The above revisions shall be incorporated into the final design documents.

TASK 9 PROJECT MANAGEMENT

The Project Management task will include the following subtasks:

Subtask 9.1 Team Management

Hazen and Sawyer (the Consultant) shall provide additional general project management to include oversight and coordination of the efforts, and staffing/personnel administration of sub-consultants during the project.

Subtask 9.2 Monthly Reporting and Invoicing

Under this task, Hazen shall review and issue monthly invoices as well we provide monthly report that shall update the District's project manager on the project status including the project schedule and budget

updates for the extended project duration of 4 months. Hazen shall also provide weekly updates on the work completed during the previous week and a two week look ahead on tasks to be completed.

Subtask 10.2 Coordination with Caltrans

Under this task, Hazen shall coordinate with Caltrans and the District on the permit application and answer and questions or provide clarification of information for the permit application.
