AWARD CONSTRUCTION CONTRACT (BASE BID AND BID DEDUCT) FOR THE BROWNS VALLEY TRUNK PROJECT (CIP 14703) TO JMB CONSTRUCTION INC. FOR THE BID AMOUNT OF \$20,507,752 AND AUTHORIZE THE GENERAL MANAGER TO EXECUTE THE AGREEMENT WITH THE CONTRACTOR AND ISSUE THE NOTICE TO PROCEED WHEN APPROPRIATE.

Robin Gamble Holley gave a presentation on the Browns Valley Trunk Project bid results. She reported NapaSan received four bids on the project, with one bid including the bid deduct. The engineer's estimate for the project is \$21,000,000. The low bidder is JMB Construction with a bid of \$20,507,752 after the bid deduct. Ms. Gamble Holley explained the bid deduct and cost savings, as well as the construction schedule. Total project costs, including hard and soft costs, are estimated to be \$25,634,479. Pre-construction outreach will commence in April 2020, with construction to begin this spring and an estimated completion in the fall of 2021.

Board and staff held discussion.

Robin Gamble Holley presented an overview of the West Napa Pump Station Replacement Project. She reported NapaSan received six bids on the project, with Anderson Pacific having the low bid at \$7,662,305. Total project costs are

estimated at \$10,469,661, including hard and soft costs. Engineer's estimate for the project is \$8.45M.

Gamble Holley reported NapaSan would receive a Green Project Reserve \$4M loan forgiveness due to the green components of the project. The remainder of both the Browns Valley Trunk and this project are being funded by a State Revolving Fund loan. Gamble Holley reviewed the anticipated construction schedule with construction beginning in May 2020 and project completion estimated for November 2021.

GHD will provide the construction management and inspection services for both projects, which will consist of one full-time onsite construction manager, two full-time construction inspectors, several part-time construction inspectors and specialty inspectors when necessary to monitor for compliance with the contract documents.
