David Haines: Addressed that the House and Senate are drafting a Justice in Policing Act-Policing Reform which would remove qualified immunity, decreasing liability protection for various conflicts and willfully violating rights and interactions, add requirements for DOJ funding for local governments, and add in bias training, training for de-escalation tactics.

Steve Palmer: Addressed the Invest in America Act- unfunded transportation tax; Appropriation bill process; and the Hero's Act.
