Background

- 15,400 LF (~3 mi. length)
- 66" RCP unlined
- Criticality
 - Conveys over 90% of flow to SWRF
 - Parallels the Napa River
 - No redundancy

Project Scope

- Structural rehabilitation (CIPP) of downstream 1.3 miles of trunk main (south of Kaiser Road)
- Manhole construction / reconstruction / replacement to facilitate liner installation

CEQA

- Biological resources
 - 19 mitigation measures (federal and state endangered/protected species, sensitive wetland habitats)
 - Pre-construction biological surveys
- Wetland/riparian avoidance and permits
- Tier 4 equipment (air quality)
- Cultural resources

Discrepancy Between Bids and Engineer's Estimate

- Estimate based on unit pricing for similar projects in northern California over past 5 years.
 - Average lining costs \$12.10/inch dia.
 - Bid average \$7.85/inch dia.
- Bypass costs 34% lower than estimated
- 10% contingency included in estimate
- Typically only 1-2 bidders for this type of work.
 3 bidders indicates aggressive bidding climate.
