

Good afternoon Ms. Griffis,

Thank you for transmitting your Local Government's Proof of Designation (POD) for the Covered Electronic Waste (CEW) Recovery and Recycling Payment System provided for through California's Electronic Waste Recycling Act of 2003 (SB20).

This email serves as confirmation that the POD attached to this email was postmarked or received electronically on **December 1, 2021**. Your Designated Approved Collector (DAC) may begin collecting CEW on your behalf on or after **January 1, 2022**. CalRecycle will continue to review your POD and our office will inform you or your DAC of any concerns. You may amend or terminate the POD at any time by notifying our office and your Designated Approved Collector.

NOTE: Although you have submitted a new designation, you may still receive an auto-generated email reminder that the current (01/01/2021 – 12/31/2021) designation will expire. You do not need to respond.

Both your signature and the signature of your DAC on the POD certify that you will each operate in compliance with all POD requirements as outlined in the regulations governing participants in our payment program. As a reminder, your DAC must also report their CEW collection activities to you at least annually on or before September 1 for you to include on your [CalRecycle Form 303 Household Hazardous Waste Collection Information](#). Your issuance of this designation allows your DAC to be exempt from certain California "name and address" CEW source documentation requirements for materials collected on your behalf. However, your DAC must provide collection logs upon the transfer of CEW materials collected to approved participants in our program 14 CCR 18660.20(j)(1)(A)-(B). Additionally, your DAC's collection logs must include separate entries for each non-residential discard of 5 or more CEW units 14 CCR 18660.20(j)(1)(C).
