ISSUE STATEMENT:

Interview applicants and make appointment to fill one unexpired term as the City of Napa representative to the Napa County Measure "A" Financial Oversight Committee.

DISCUSSION:

The City Clerk Department conducted a recruitment to fill one unexpired term as the City of Napa representative to the Napa County Measure "A" Financial Oversight Committee from September 20, 2013 through October 18, 2013. No applications were received; therefore, a second recruitment was conducted from October 25, 2013 through November 22, 2013. Subsequent to the second recruitment effort, a third was initiated on December 6, 2013.

Announcements were published on the City's website, posted at City Hall, Human Resources, and sent to the Napa County Library, Napa Valley College, Napa Chamber of Commerce, Napa Valley Unified School District, Queen of the Valley, Napa County Board of Supervisors, Napa County Administration, Napa County Hispanic Chamber of Commerce, Napa County Hispanic Network, Napa Valley Coalition of Non-Profit Agencies, Napa Valley Community Housing, Puertas Abiertas Community Resource Center, and Leadership Napa Valley.

As a result of our continuous recruitment efforts, two applications were received. One of the applicants does not live within Napa City Limits. After research, we have found that the guidelines and bylaws for the Measure "A" Financial Oversight Committee are silent on the matter of residency requirements. It is at the discretion of the Council.

The Napa County Measure A Financial Oversight Committee (FOC) consists of seventeen Napa County citizens who are appointed by the Napa County Board of Supervisors based upon recommended names. There is one City of Napa representative vacancy with a term effective the date appointed by the County Board of Supervisors and ending June 30 2015.

The purpose of the FOC is to inform the public on expenditures of Flood Protection Sales Tax proceeds generated as a result of the enactment of Measure A. Members should have a strong understanding of the type and nature of expenditures associated with a public project of this magnitude, and be able to review budgetary documents with a particular emphasis on capital project expenditures.
