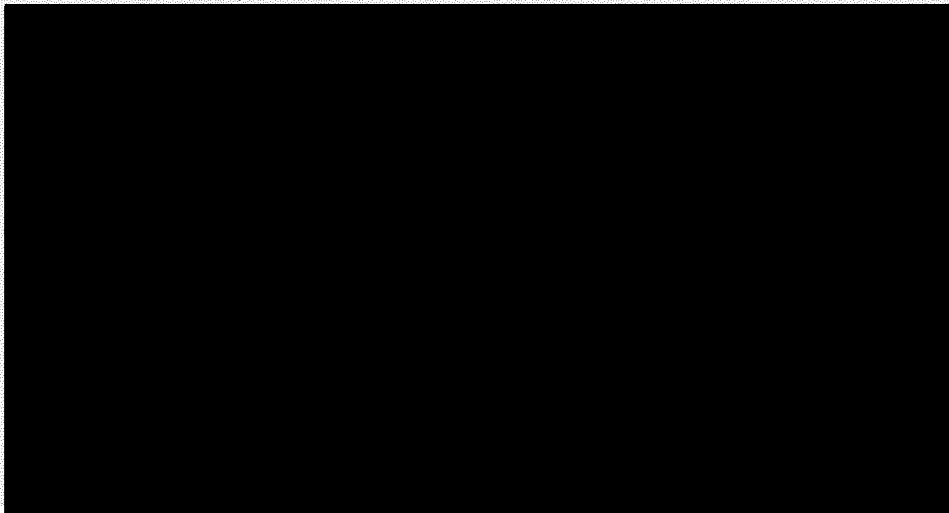

Reinhard Fritz "Fred" Rijke

Born and raised in the Netherlands. Graduated from "Nyenrode" Netherlands Business University. Served in the Royal Netherlands Army as CFO of a Battalion.

Work Experience:

1961-1966 N.V. Philips, Eindhoven, the Netherlands. Held international marketing positions in Consumer Goods Divisions.

1967-1978. American Optical Corporation, a subsidiary of Warner Lambert Co. This was the largest company in the world making and selling consumer optical goods, medical instruments, medical electronics and safety products.

1967. International Advertising Manager. Southbridge, Ma.

1970. General Manager-Caribbean. San Juan, Puerto Rico.

1973. Area Director- Asia. Hong Kong

1976. Vice President Europe. Basel, Switzerland. Supervised subsidiaries in 8 countries. Several factories, head count of about 3000.

1978-2003. TASA Worldwide and its successors TMP Worldwide and Hudson Highland Worldwide .

Was invited to join a Swiss International Executive Search Firm.

1978. Moved to Miami as Managing Partner for a new office that became Head Quarters for the firm's operations in Latin America. Handled a variety of Executive Search assignments, mainly related to Latin America.

1984. Managing Partner-New York Office. Handled mainly international assignments and was responsible for the second largest office of the Firm.

1995. Executive Search Consultant. Stepped down as Managing Partner to concentrate on client service. Elected to the Firm's Board of Directors.

1998. TASA was acquired by TMP Worldwide (also owner of Monster.com) . TMP quickly acquired a number of large and small search firms. Was instrumental in merging firms. Served as Managing Partner New York, then as Head of USA .

With another acquisition came a new President for the Executive Search Division, which was now the fifth largest Search Firm in the world. Member of Executive Committee.

When the business contracted severely after the stock market crash, then 9/11, helped to downsize the company, closing operations and terminating consultants and staff.

2002-August 2003. Head of Latin America. . Moved to the Corporate Staff and was responsible for TMP's operations in Latin America. Restructured, downsized and divested. When the job was done, took retirement.
