Charles Morse, (aka Chuck) has practiced general civil law in Napa since 1981, emphasizing Trusts and Estate Planning and administration.

He served approx. 9 years in the U.S. Navy (April 1960 to March 1969) as a Crypto Repairman i.e. Communications Technician – Maintenance Branch. He was honorably discharged as a First Class Petty Officer (E-6) He held a Top Secret – Crypto security clearance. Chuck has a service connected disability.

Chuck took his undergraduate studies at Napa Valley College, University of Hawaii, and Bridgewater State College in Massachusetts. He received his Juris Doctor from Armstrong College in Berkeley, California in 1981 while working as an aviation electronics technician for Silverado Avionics at Napa County Airport. From about 1981 to 1990, he worked an Electronics Systems Engineer for two companies supporting Mare Island. He was admitted to the California Bar that same year. Virtually all of his education was achieved while on active duty, or under the G.I. Bill.

When first admitted to the California Bar, he served as a Senior Advocate for Napa County Legal Assistance Agency (1981-82), assisting seniors with a variety of legal issues. A part of his duties was to provide legal counseling at the Veteran's Home in Yountville. For portions of 2003 and 2004 Chuck held a regular, one-day per month legal clinic for residents of the Veterans Home.

For several years, Chuck contracted with Redwood Caregiver Resource Center to provide low-cost legal services to families of brain-damaged adults.
