We are writing to inform you about Napa County's Preschool for All Advisory Committee and to ask

Special Education Services (707) 259-5904 If passed, PFA legislation will likely have a significant impact on Napa County child care centers, family child care providers and local colleges and universities. In order to meet the potential demand for PFA slots, many of the current child care providers are needed as PFA providers.

The Advisory Committee will be a working committee representative of various stakeholders in Napa County that are interested in PFA. Committee members are being recruited for their expertise and ability to articulate the implications and issues related to PFA system wide rather than focusing on a particular geographic area or type of preschool. It is anticipated that the Advisory Committee will assist in the research of supply and demand as well as conduct community outreach.

The Advisory Committee responsibilities will be:

- Providing an on-going commitment by the persons involved in the project or, if such commitment cannot be sustained, to promptly notify the chairperson.
- Conducting research and providing information needed to conduct the project including completing worksheets and supply and demand tasks.
- Identifying areas for community outreach, the child-care and translation needed and conducting community outreach in various areas in Napa County.
- Arranging to document outreach activities and submitting results to SEI.
- Attending the scheduled meetings, planning teleconference sessions, and participating in decision-making.
- Reviewing each major project deliverable and either accepting or rejecting with specific comments on issues to address.

Throughout the project, there will be structured decision making sessions and documentation of all decisions. Funding for the consultant and administrative assistant costs are provided through First 5 Napa County Children and Families Commission.

The kickoff meeting for the Committee will be February 24, 2006 from 8:30 – 12:30 at NCOE located at 2121 Imola Avenue, Napa. At this meeting, the PFA facilitator will review the planning activities, timeline and solicit feedback regarding the approach and additional stakeholders to involve. The project calendar, meeting times and locations will be decided.
