JAMES THOMAS BAILEY is Director of Theatre and Chair of the Visual and Performing Arts Department at Justin-Siena in Napa. In addition to his work with Justin-Siena, he leads an active professional life as an artist. He is Artistic Director of CSz Los Angeles, and is producer and director of ComedySportz, the longest running show in the city's history. His improvisational production of Chickspeare has toured California and played at the Oregon Shakespeare Festival during the last three seasons. He founded and directs the largest teen improv program in the United States, serving more than 70 schools and 1200 students annually. In addition, Mr. Bailey has produced more than fifty shows in Los Angeles, including many west coast, American and world premieres. He has appeared on television, in many national commercials and in more than forty stage productions. Mr. Bailey is in demand as a creative consultant/trainer and his clients include such powerhouses as Walt Disney, ABC, Nestle, SONY Pictures and Coca-Cola, among others. He is a Cultural Specialist for the U.S. State Department and has taught at the Fulbright Center in Cyprus for the American embassy. Mr. Bailey is past-president of the California Educational Theatre Association (CETA). He was inducted in the California Thespian Hall of Fame, and has received CETA's highest honor, the CETA Medallion, in recognition of his dedication to theatre education. He has served on numerous boards and committees, including LAUSD Blue Ribbon Panel on Arts Education and grant committees for the City of Los Angeles Cultural Affairs Department.
