I work in Napa. I work and have worked for several banks over much of my career and I have involvement in the wine and vineyard business in Napa that dates back almost 40 years. Over my years, I have worked with the likes of Robert Mondavi, the folks at Christian Brothers before they sold, Dr. Jan Krupp, Robin Baggett, Robin Lail and many many others. In the early 2000's, I worked for a winery in Sonoma for two years as well. I know this business well.

Yours is a difficult job - balancing the needs of the industry, the community and neighbors - someone is invariably not happy whatever you decide.

As relates to the Caldwells, I believe they are the prototype of the kind of project that should be supported. Why?

- Family owned and run winery. Legacy matters to the Caldwells.
- An estate winery they make what they grow
- John and Joy's passion, drive and vision are part of why there is a Coombsville AVA today.



Across the country small family farms are dying and with them a way of life. These wonderful family farms are being gobbled up by giant agribusinesses which only care about quantity NOT quality. I have witnessed beautiful family farms which produced incredibly high quality produce sold off for residential development or to larger farming concerns. We see some of these same trends in Napa. If you consider the massive barriers to entry for anyone wanting to start a family vineyard in Napa, then you must see the necessity for doing everything you can to help current family vineyards remain viable. The difference in the cost of acreage 20 plus years ago versus today is astronomical. The long standing joke among small vineyards is if you want to make a million dollars growing grapes and making wine in Napa, then you need to spend \$10 million is probably not far off the mark. If we can agree that keeping these amazing family vineyards viable is of the utmost importance, then it seems that the Board of Supervisors should be looking to help them within the framework of legitimate safety and smart growth concerns.

Ms. Balcher and Planning Board,

I am writing to you in support for the Caldwell Winery request to expand production and visitation.

Before deciding to write you a letter in support of Caldwell, I reviewed previous requests to your board, including the 2017 Reynolds Case (P14-00334) on Soda Canyon Road. I have no interest in writing you a letter of blind support without putting in consideration and effort. I do not pretend to be unbiased in this matter - I am a longtime supporter of John and Joy and I am one of the first 150 members of their wine club. Caldwell is an important and special place for me.

That said, I have spent considerable time reviewing the matter and previous cases, and believe that the request is reasonable and valid. I do not offer you blind allegiance.

The number of requests Caldwell has fulfilled for the neighbors - acting as individuals, with specific, and often selfish requests - shows a willingness to work with the community. That said, the planning board has shifted the responsibility from the board to the neighborhood, which does not have the mandate to work within the traffic, safety, and other important mandates of the county. The requests (And denials) are without structure or precedent. Your own staff as indicated the request meets the country requirements.

I urge you to support small, family business - far from the very un-Napa-like Route 29 behemoths - not by simply giving in to a request because they are a small family business, but by brokering a peace between the neighboorhood and the winery that meets the standards of the law, while supporting what Napa is truly about.

I realize I am not a citizen of your community, living nearly 1.5 hours south of your location. I have no illusions that my voice is as valued or respected as someone who lives and works in your area, but as a frequent visitor and significant contributor to your economy, I hope I can present a point of view that is both logical and reasonable.
