# 1. CALL TO ORDER; ROLL CALL

The Board of Supervisors of the County of Napa met in regular session on Tuesday, February 26, 2019, at 9:00 a.m. with the following supervisors present: Chair Ryan Gregory and Supervisors Diane Dillon, Alfredo Pedroza, Belia Ramos and Brad Wagenknecht. The meeting was called to order by Chair Ryan Gregory.

2. PLEDGE OF ALLEGIANCE

Chair Ryan Gregory led the assembly in the pledge of allegiance.

Director of Planning, Building, and Environmental Services (PBES) requests that the Board of Supervisors:

 Find that the proposed Water Quality and Tree Protection ordinance (proposed ordinance) is consistent with the Napa County General Plan (2008);

- 2. Find the proposed ordinance exempt under the California Environmental Quality Act pursuant to Categorical Exemptions Class 7, Class 8, Class 4, Class 5 and the General Rule; and
- 3. Adopt the proposed ordinance.

ENVIRONMENTAL DETERMINATION: Consideration and possible adoption of Categorical Exemptions Class 7, Class 8, Class 4, Class 5 and the General Rule. It has been determined that this type of project does not have a significant effect on the environment and is exempt from the California Environmental Quality Act. [See Categorical Exemption Class 7 ("Actions by Regulatory Agencies for Protection of Natural Resources") which may be found in the guidelines for the implementation of the CEQA at 14 CCR §15307]; Categorical Exemption Class 8 ("Actions by Regulatory Agencies for Protection of the Environment") which may be found in the guidelines for the implementation of the CEQA at 14 CCR §15308]; Categorical Exemption Class 4 ("Minor Alterations to Land") which may be found in the guidelines for the implementation of the CEQA at 14 CCR §15304; see also Napa County's Local Procedures for Implementing the California Environmental Quality Act. Appendix B]; Categorical Exemption Class 5 ("Minor Alterations in Land Use Limitations") which may be found in the guidelines for the implementation of the CEQA at 14 CCR §15305; see also Napa County's Local Procedures for Implementing the California Environmental Quality Act, Appendix B]; and General Rule in that it can be seen with certainty that there is no possibility the proposed action may have a significant effect on the environment and therefore CEQA is not applicable. [See Guidelines for the Implementation of the CEQA 14 CCR 15061(b)(3)]. This project is not on any lists of hazardous waste sites enumerated under Government Code Section 65962.5.

Chair Ryan Gregory introduced the item and opened the public hearing.

Planning, Building and Environmental Services Director David Morrison made presentation. Planning, Building and Environmental Services Department Supervising Planner Brian Bordona and Deputy County Counsel Laura Anderson provided additional information.

Held discussion.

Fire Chief Barry Biermann made presentation.

Sixty-four (64) people spoke during public comment.

Chair Ryan Gregory closed the public hearing.

During the course of discussion, Chair Ryan Gregory conducted property disclosures by Board Members. There were no relevant property disclosures reported by any member of the Board.

The Board provided direction to staff regarding various modifications to the proposed ordinance as recounted by County Counsel. Chair Ryan Gregory recessed the meeting until 6:15 p.m.

Following the evening recess, the Board reconvened the meeting session at 6:15 p.m.

Chair Ryan Gregory recognized Planning, Building and Environmental Services Director David Morrison who deferred to County Counsel Jeffrey M. Brax.

County Counsel Brax recounted the changes to the proposed ordinance as follows:

- 1. Allowing development on 30 percent slope with a use permit. Mr. Brax advised that staff added back in the following language, "uses prohibited without an exemption or an exception".
- 2. The Planning Commission's recommendation towards grading improvements to an existing roadway or driveway has been removed because the proposed exemption is broader than the one proposed by the Planning Commission.
- 3. In Subsection B, the existing con regs included a prohibition on over 50 percent slope so that language was put back in.
- 4. The existing Subsection B became Subsection C on Page 1.
- 5. In the middle of Page 2, a conforming revision to Section 18.108.040, is to state an exception in the form of a use permit may be granted to any of the requirements of this chapter other than Subsection B of Section 18.108.060.
- 6. In 18.108.020, the first change including applying the tree requirements in the Agriculture Watershed (AW) only.
- 7. The strikeout at the bottom of page 2 reflects that the shrub land/chaparrals will not be extended beyond the municipal reservoirs.
- 8. At the top of page 3, added in the AW Zoning District again under Part D.
- 9. Revised the Vegetation Removal Mitigation to reflect the Board's intent. Removal shall be mitigated at a minimum 3:1 ratio unless otherwise set forth below.
- 10. In Subparts 1, 2 and 3 deleted references to prior 2:1 ratio and all other unnecessary 3:1 references as this ratio now resides in the preamble.
- 11. New Part 5, states, "Alternatively, the removal of any vegetation canopy cover may be mitigated by permanent replacement or preservation of comparable vegetation canopy cover, on an acreage basis at a minimum 2:1 ratio, where the project includes substantial public benefits as determined by the director".
- 12. Change to Section 18.108.025 B (3) that deletes, "ORDINARY HIGH WATER MARK" so stream setbacks will be measured from the top of bank.

- 13. Change to Section 18.108.026 allows flexibility for wetlands as in some limited circumstances the 50 percent setback has been reduced if recommended by a qualified professional biologist and approved by the director.
- 14. Revision to 18.108.027(G) attempts to embody the Board's direction regarding setbacks to 500 feet for Kimball and Bell Canyon Reservoirs or within 200 feet for all of the others. Again, top of bank vs. high water mark.
- 15. Revision to 18.108.030 includes changes to several of the definitions including deleting "Chaparral", revising the definition of Defensible Space to match Section 8.36 in the Napa County Defensible Space Guidelines, revising municipal reservoirs sensitive domestic water supply to break out Friesen Lakes as well as in the list of them one through seven in that definition.
- 16. On the top of Page 5, deleting the word "shrub" as it is superfluous with shrub land.
- 17. Adding the definition of Track II Vineyard Replants which comes into play for a later amendment.
- 18. In Section 18.108.050(H) is the Fire Exemption which reads, "Creation and/or maintenance of defensible space for legally constructed structures or the implementation of fire management strategies completed under the guidance of the California Department of Forestry and Fire Protection".
- 19. In Section 18.108.080(D) deletes a provision that was previously included that staff now prefers to delete.
- 20. One of the changes from the Resource Conservation District Resource Conservation District (RCD) includes a change to the title of the soil erosion specialist.
- 21. New Section 18.108.090(G) reads, "Track II vineyard replants shall be ministerial within the meaning of the California Environmental Quality Act, as set forth in Subsection A of Section 18.108.055 and Napa County's Local Procedures for Implementing the California Environmental Quality Act".
- 22. Changes to the title of the Natural Resources Conservation Service (NRCS) as outlined on the bottom of page five and on to the top of Page 6.
- 23. Proposed revision to Section 18.108.140(A)(1)(c) per the RCD: c. Is located in an area determined to have severe soil erosion hazard as determined by the director based on the Napa County Soil Survey prepared by the NRCS, incorporated herein by reference".
- 24. Proposed revisions to Section 17 (uncodified), with regard to the five (5) acre exemption, staff agrees that can be up to 30 percent. If new vineyards are proposed over 15 percent, they will have to go through CEQA but they would be exempt from the requirements of the new ordinance and they would be subject to the con regs instead.
- 25. An exception was added for specified priority housing development sites identified in our affordable housing combining district some of which may overlap with the AW

Page 7 of 10 03/26/2019 which are exempted from the new ordinance to ensure maximum protection of the County's affordable housing sites.26. Section 19 includes a severability clause.

Held additional discussion.

Chair Ryan Gregory directed the Clerk of the Board to read the title of the proposed ordinance.

Clerk of the Board Jose Luis Valdez read the title of the ordinance as directed by Chair Gregory.

Motion by Diane Dillon, Second by Brad Wagenknecht, to waive the balance of the reading of the ordinance. Motion passed 5 – 0 with Chair Ryan Gregory and Supervisors Diane Dillon, Alfredo Pedroza, Belia Ramos and Brad Wagenknecht voting yes.

Motion by Diane Dillon, Second by Alfredo Pedroza, to adopt the ordinance as revised. Motion passed 5 - 0 with Chair Ryan Gregory and Supervisors Diane Dillon, Alfredo Pedroza, Belia Ramos and Brad Wagenknecht voting yes.

Prior to the Board's vote on this measure, Supervisor Brad Wagenknecht asked that the record reflect that the Board would be provided an update by staff within one calendar year from adoption of the proposed ordinance. Chair Ryan Gregory asked that the record reflect the same and it was duly noted by the Clerk of the Board.

Motion passed 5 – 0 with Chair Ryan Gregory and Supervisors Diane Dillon, Alfredo Pedroza, Belia Ramos and Brad Wagenknecht voting yes.

Chair Ryan Gregory announced that the second reading of the ordinance would take place during the Board of Supervisors meeting on April 9, 2019.
