

**RESOLUTION 2006-107**

**A RESOLUTION OF THE CITY COUNCIL OF THE  
CITY OF AMERICAN CANYON CALLING AND GIVING NOTICE OF A GENERAL  
MUNICIPAL ELECTION TO BE HELD ON  
TUESDAY, NOVEMBER 7, 2006, FOR THE ELECTION  
OF AN ELECTED MAYOR AND TWO CITY COUNCILMEMBERS**

**WHEREAS**, the City Council of the City of American Canyon calls and gives notice of a general municipal election to be consolidated with the statewide primary election on Tuesday, November 7, 2006.

**NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF AMERICAN CANYON, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:**

**Section 1.** That pursuant to the requirements of the laws of the State of California relating to general law cities, there is called and ordered to be held in the City of American Canyon, California, on Tuesday, November 7, 2006, a General Municipal Election for the purpose of electing a Mayor for two years, and two Councilmembers for four year terms. All of the offices must be filled by a majority vote.

**Section 2.** That the ballots to be used at the election shall be in form and content as required by law.

**Section 3.** That the County Clerk is authorized, instructed and directed to procure and furnish any and all official ballots, notices, printed matter and all supplies, equipment and other necessary items in order to properly and lawfully conduct the election.

**Section 4.** That the polls for election shall be open at 7:00 a.m. of the day of the election and shall remain open continuously from that time until 8:00 p.m. of the same day when the polls shall be closed, except as provided in Section 14401 of the Election Code of the State of California.

**Section 5.** That in all particulars not recited in this resolution, the election shall be held and conducted as provided by law for holding municipal elections.

**Section 6.** That notice of the time and place of holding the election is given and the County Clerk is authorized, instructed and directed to give further or additional notice of the election, in time, form and manner as required by law.

**Section 7.** That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.





**RESOLUTION NO. 2006-108**

**A RESOLUTION OF THE CITY COUNCIL OF THE  
CITY OF AMERICAN CANYON, REQUESTING THE BOARD OF SUPERVISORS  
OF THE COUNTY OF NAPA TO CONSOLIDATE A GENERAL MUNICIPAL  
ELECTION TO BE HELD ON NOVEMBER 7, 2006 WITH THE  
STATEWIDE GENERAL ELECTION.**

**WHEREAS**, the City Council of the City of American Canyon has called and given notice of a General Municipal Election to be held on November 7, 2006, for the purpose of electing two City Councilmembers to the City Council and a Mayor; and

**WHEREAS**, it is desirable that the Election be consolidated with the Statewide General Election to be held on the same date, and that within the City, the precincts, polling places, and election officers of the two elections be the same, and that the County Elections Department of the County of Napa canvass the returns of the General Municipal Election and that the election be held in all respects as if there were only one election.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF AMERICAN CANYON DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:**

**Section 1.** That pursuant to the requirements of Section 10403 of the Elections Code, the Board of Supervisors of the County of Napa is hereby requested to consent and agreed the consolidation of a general municipal election with the Statewide general election on Tuesday, November 7, 2006, for the purpose of the election of two members of the City Council and a Mayor.

**Section 2.** That the County Election Department is authorized to canvass the returns of the Election. The election shall be held in all respects as if there were only one election, and only one form of ballot shall be used.

**Section 3.** That the Board of Supervisors is requested to issue instructions to the County Election Department to take any and all steps necessary for the holding of the consolidated election.

**Section 4.** That the City of American Canyon recognizes that additional cost will be incurred by the County by reason of this consolidation and agrees to reimburse the County for any costs.
