

Measure A Financial Oversight Committee

Background:

After passage of Flood Control Measure "A," in March 1998, adding ½ cent to the County sales tax, the County formed the Measure A Financial Oversight Committee.

The Oversight Committee's job is to:

- Review expenditures of funds;
- Keep the public informed on how and where the expenditures are made;
- Review financial impacts of all projects approved by the Authority; and
- Make recommendations to the District regarding replacement projects.

The Council recommended Renate Halliday for appointment to the County of Napa in September 2003 and her term is scheduled to end on June 30, 2006. The Town has received a request from the County to recommend an individual to serve on the Committee for the term ending June 30, 2009.

Mrs. Halliday has indicated she is still interested in being Yountville's representative to the Financial Oversight Committee and Staff feels she would be an excellent choice to continue to represent Yountville.

Recommended Action:

1. Direct staff to forward Council's recommendation for appointment of Renate Halliday to the Measure A Financial Oversight Committee as the Yountville Representative.
