

from successful treatment, while it may take a long time, is especially rewarding: we				
can help youth avoid the tragedies and wasted lives that make adults easier to treat.				
I have been working with and for youth who are wards of the court since the early				
'70's. This work has included putting a puppet on my hand to tell cautionary tales				
to middle-schoolers in the early '70's, camping and backpacking with juvenile				
delinquent drug abusers at Tioga Pass, assessing and tutoring drug abusing gang				
members, to developing programs and data systems that comply with funding				
requirements. I have been involved in opening and operating several group homes				
for drug abusing wards of the court, and have helped to establish counseling programs				
for youth referred by the courts or by school discipline systems.				
I have had a unique opportunity to work in and to help develop an unusual variety				
of programs for the vouth on probation. I have been able to do this work in a private				
(non-profit) sector, supported through fee-for-service contracts: where funding				
depends on marketing and results, not grants. As a consequence I believe I can offer				
a different perspective to the board and to the county.

Resume for William Ray Krimm

1972-1977 Rural Programs and Community Outreach Coordinator at the Olive Street Bridge, Fresno CA

Led a team which provided drug abuse alternative and prevention programs as well as treatment services and public education to primarily rural, Hispanic communities in Fresno County. A major focus was alternatives programming to at-risk Hispanic youth.

Major accomplishments:

"Arriba" a youth club in southeastern Fresno Co. (Sanger area) which exposed first through third generation Hispanic immigrant adolescents to activities beyond the horizons of their immediate communities and neighborhoods. This included backpacking and camping trips.

"Little People Theater" a traveling puppet show for (and at times by) younger children. The puppets acted out plays designed to instill positive self-esteem and social problem solving skills.

1977-1983 Merced County Alcohol and Drug Program Administrator

Administered the county's drug and alcohol abuse programs. Responsible for budgeting, planning and controlling expenditures. Developed annual plans and program evaluations. Provided direct services at times. Managed and supervised staff of outpatient, residential and prevention programs.

Major accomplishments:

Surviving Proposition 13. We maintained and even expanded programs in part by using antipoverty funding for staff.

Moving the County's programs away from a mental health model toward alcohol and drug abuse treatment. Hiring notorious, local ex-addicts as counselors.

Establishing a traveling puppet show for primary grade children.

Serving two terms as vice president and several terms as rural counties chair in the California Association of Drug Program Coordinators. Helped to develop the original Drug Treatment Standards for California and publicized (though did not solve) the discrepancy between rural and urban counties in per capita funding for drug and alcohol services.

1983-1986 Drug Program Analyst, Sonoma County

Served as Assistant County Drug Program Coordinator; developed budgets and annual plans, and oversaw expenditures; negotiated and monitored contracts.

Major accomplishments:

Replicating the National High School Drug Use Survey in Sonoma County and integrating it into a comprehensive Drug Abuse Needs Assessment.

Bringing the Office into the computer age by putting the first personal computer into place and developing management information systems including putting the first drug program budget on a computer spreadsheet and creating a computerized database of contractor activities.

1987-1991 Associate Director, The R House, Santa Rosa CA.

Administered payroll, human resources and did program development for a residential alcohol and drug treatment services to adolescents placed by the criminal justice system.

Major accomplishments:

Opening four new sites, outside Sonoma County, which more than doubled the program's capacity.

Developing the agency's computer-based employee data and payroll management information system.

Developing the agency's program of camping, rafting and other outdoor activities for residents.

1991-1998 Non-Public School Administrator and Special Programs Developer, Our Family, Napa CA

Developed and managed the non-public school which significantly benefited the agency educationally, programmatically and fiscally, and took the lead on special projects or crises.

Major accomplishments:

Founding and administering the private, on-grounds special education high school, Unity H.S.

Serving two terms as President of the California Association of Children's Homes.

Serving one term as President of CAPSES: state-wide special education services organization

Developing a Drug MediCal outpatient program and Federally funded school breakfast/lunch program.

1998-2003 Chief Information Officer, Alternatives for Better Living Napa, CA

Providing a variety of data management and program development services for a fledgling non-profit outpatient counseling program.

Major accomplishments:

Helping the program achieve 501 (c) 3 status; developing a client database; developing school-based substance abuse treatment for adolescents, developing Case Management program for Napa's Adult Drug Court.

2003-Present Executive Director, Alternatives for Better Living Napa CA

Major accomplishments:

Expanding school-based substance abuse treatment; developing anger management services for youth; developing adult misdemeanor services for the Napa courts i.e. PC 1000 and Misdemeanor Diversion; opening two Clean and Sober Homes for Napa adults.

Creating specialized computer management information systems (i.e. employee and client databases) for various organizations including Napa County Juvenile Drug Court, San Francisco Adult Drug Court, Genesis Family Center (Fresno), and California Services for Children
