HOWEVER, HE CANCELLED THE TRIP IN ORDER TO ATTEND HEARINGS ON THE EVANS HOUSING BILL IN SACRAMENTO. SUPERVISOR TIM SMITH FROM SONOMA COUNTY WILL REPRESENT THE NORTH BAY IN D.C.

SUPERVISOR DODD ALSO ANNOUNCED THAT ON THURSDAY HE WILL SERVE ON AN ASSOCIATION OF BAY AREA GOVERMENTS (ABAG) PANEL FOCUSING ON DISSCUSION OF THE SMART GROWTH STRATEGY/REGIONAL LIVABILITY FOOTPRINT PROJECT.

SUPERVISOR DILLON REPORTED ON HER ATTENDANCE AT A MEETING OF THE NAPA COUNTY LEAGUE OF GOVERNMENTS (NCLOG) HELD LAST THURSDAY EVENING. SHE EXPRESSED CONCERN OVER THE LACK OF CITY REPRESENTATION AT THE MEETING AND SUGGESTED THAT PERHAPS ANOTHER VENUE SHOULD BE CONSIDERED TO DISCUSS COUNTYWIDE TOPICS OF CONCERN.

SHE FURTHER NOTED THAT IN MAY THE JOINT POLICY COMMITTEE WILL RELEASE POLICY INITIATIVES REGARDING CLIMATE CHANGE.

SUPERVISOR WAGENKNECHT REPORTED ON A NAPA VALLEY CONFERENCE AND VISITORS BUREAU SYMPOSIUM HE ATTENDED WITH SUPERVISOR LUCE LAST THURSDAY. THE BRANDING STRATEGY WAS ONE OF THE MAJOR TOPICS OF DISCUSSION.

SUPERVISOR WAGENKNECHT ALSO REPORTED ON HIS ATTENDANCE AT A FIRST 5 (CHILDREN AND FAMILIES COMMISSION) ON MONDAY. FIRST 5 IS IN THE PROCESSING OF DETERMINING THE DISTRIBUTION OF THEIR GRANT FUNDS.
