During my tenure as president of Napa Valley Vintners in the late 1980's, I was actively involved in County regulatory matters affecting the wine industry. A significant issue confronting Napa County and the wine industry is the unavailability of low and moderate cost housing for agricultural and winery employees. Adequate farmworker housing is a small but important piece of the larger problem, and I am interested in using my experience to assist the County and the industry in the provision and operation of such housing.
