


The term of your position representing the Business Community on the Financial Oversight Committee expires on June 30, 2007.

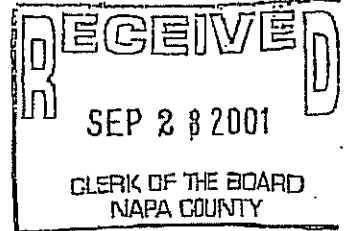

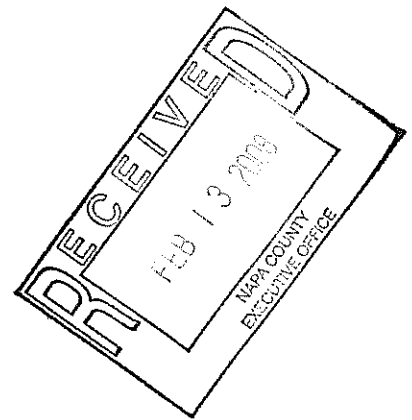
