**The May Revise was released. Funding for Property tax backfill as a result of the fires was increased. Estimates for schools were revised as well and they will receive their funding through Prop 98. Governor elected in the May Revise to include \$29 million for the Local Government cost share for debris removal. Governor did include one-time funding for**

**homeless services—mirrors what the California State Association of Counties advocacy efforts.**
