July is the American Academy of Ophthalmology's UV Safety Month. Ultraviolet (UV) radiation is the main cause of skin cancer. Additionally, overexposure to UV rays can damage our eyes. Everyone is susceptible to getting skin cancer, but the risk is greatest for people with white or light-colored skin with freckles, blond or red hair, and blue or green eyes.
