Is there ever an excuse to not work safely? In one sense or another we get confronted with this question every day. There are deadlines and people looking over our shoulders (sometimes literally), or the weather is nasty and we want to take that little short cut to get the job done quicker. All the pressures and temptations we face every day ask this same question: "Is there ever an excuse not to work safely?" Statistics show that the vast majority of industrial injuries are the result of people doing something that they know is unsafe. We might think that the rule can be broken just this once. However, the reason most company safety rules and occupational health and safety legislation is in place is due to someone being seriously injured or killed while not following the safest work practice. If you think what you are about to do is unsafe, it probably is. Stay safe, stop and think about it.
