4. SAFETY MOMENT - Portable Space Heater Safety

Portable electric space heaters are a common secondary source of heat at home and in the work place. The use of Portable electric space heaters is regulated by the California Fire Code (CFC 605.10.1 – 10.4). To help ensure you're using portable electric space heaters in a safe and secure manner, follow the following safety fire codes and guidelines: All heaters shall be listed and labeled with a UL (Underwrites Laboratory) stamp or sticker, and shall be plugged directly into an approved receptacle. Portable, electric space heaters shall not be plugged into extension cords, and shall not be operated within 3 feet of any combustible materials. Lastly, portable, electric space heaters shall be operated only in locations for which they are listed.
