4. SAFETY MOMENT - Sleep Awareness

March 14-20 is the National Sleep Foundation's National Sleep Awareness Week. This week-long campaign is designed to celebrate the health benefits of sleep. Each year numerous accidents are caused by fatigue, drowsy driving, and personnel in safety sensitive occupations not getting the proper sleep they need to perform safely. During this week health care professionals set aside time to review their diagnosis and treatment protocols for insomnia, sleep apnea, and narcolepsy along with common comorbidities, such as hypertension, diabetes and obesity.
