The project area is mostly bound by Redwood Rd. to the north and Solano Ave. to the west. There are a few manholes north of Redwood Rd. on Oxford St. and Tokay Dr. The project area also consists of the intersection of Jefferson St. and Trancas St. and north of Trancas St. The project also is west of Jefferson St. along Sierra Ave. and on Silverado Trail between Clark St. and Alabama St. The area also includes a manhole on Trailer Park Rd. and Solano Ave., one off of Byway East and Salvador Ave, one on Shurtleff Ave. south of Seville Dr., one on Garfield Ln. and one at the corner of Griffen Ln. and Serendipity Way.
