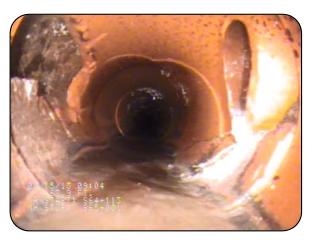

Project	Budget Reduction

Project Modifications in Years 3-10

- \$2.5M budget reduction in Years 3-10
- Reduced budgets and/or delayed projects to accommodate the deferred projects from Years 1&2. Examples:
 - Kirkland Recycled Water Pipeline
 - Pond 1 Dredge
 - Trunk Main Rehabilitation Projects
- Total budget reduction in 10-Year CIP: \$7.2M

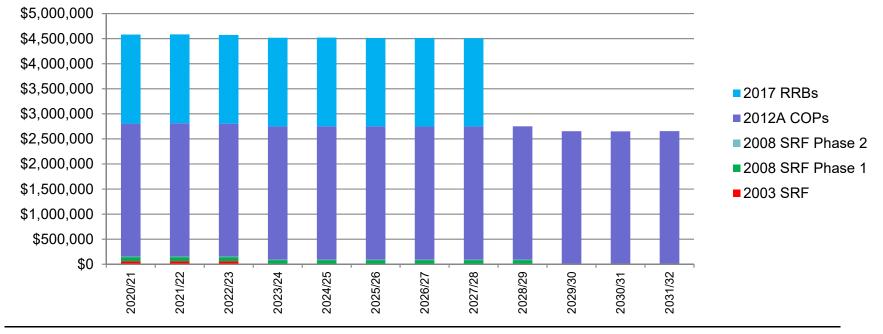
