Whereas, Amendment No. 1 to Task Order No. 2 in the amount of \$74,250 was executed on **Feburary 6, 2020**, to provide additional CEQA analysis. The authorized Not-to-Exceed fee for providing Task Order No. 2 and Amendment No. 1was \$549,602; and

Whereas, it is necessary to Amend said Task Order to provide for additional professional services not included in the original Task Order, as set forth below:

#### Reasons for Amendment No. 2 budget increase:

#### **Task 5 Scope Additions:**

#### Task 5.2:

- 1. Work to address requests for more information made by the Regional Water Quality Control Board in May of 2020. Work was completed by WRA.
- 2. Complete rare plant surveys and associated report. This work was completed in May and June of 2020 by WRA with some oversight by W&C.
- 3. Preparation of a Mitigation Monitoring Plan (MMP) to address the impacts identified by the Regional Water Quality Control Board. Based on the information provided by the Regional Board, the proposed project will temporarily impact up to 0.765 acre of brackish and freshwater marsh from vegetation clearance, and up to 0.04 acre of seasonal wetland, riparian area, and brackish marsh from CIPP Liner and Manhole excavation activities. Work to be authorized following authorization of this amendment. Majority of the work will be completed by WRA with some oversight by W&C.

#### Task 5.3:

Complete permit applications and provide coordination with the RR agency for (1)
bypass crossing of the RR tracks near the IPS and (2) laying the bypass line adjacent
to the RR tracks to cross the Bedford Slough. Two separate applications will be filled
out to keep one moving forward if the other is rejected.
