Basis of Consideration

- Strategic Plan for 2019-2021:
- 6A. Evaluate current recycled water allocation policy
 - Determine whether there is a need to change the prioritization, and if there is additional or unused capacity that should be reallocated. Staff will prepare information for the Board to have meaningful conversations and provide direction to staff regarding the end-use of recycled water that may be available now and in the future.



April 2020

- Staff Recommendation
 - Maintain existing allocation policy 11-004
 - Allow time for MST/LCWD users to connect
 - Allow time for NSH/Stanly Ranch Resort to connect





- Phase 1 Recycled Water Expansion
 - Production capacity expansion to 3,700
 AFY w/ addition of 500 sqft of sand filters and other infrastructure






- Resolution No. 11-004
 - Provides Policy for Future Activities
 Associated with Recycled Water
 - Considered how Recycled Water could be served, outlining policy objectives
 - Set out initial allocation of RW among planned customers



LCWD & MST

- LCWD
 - 107 total parcels
 - 49 parcels connected (44 -'19, 40 -'18)
 - 636 AF used in 2020 (274 AF in '19, 319 -'18, 197 -'17)
 - 436 AF used in summer 2020 (450 AF allocation)
- MST
 - 70 total parcels
 - 39 parcels connected (32 -'19, 27 -'18)
 - 408 AF used in 2020 (316 AF in '19, 284 -'18, 187 -'17)
 - 316 AF used in summer 2020 (700 AF allocation)

- 2020 was the first year when recycled water distribution (3,051 AF) exceeded Napa River discharge (2,487 AF)
- 2021 recycled water distribution is already exceeding 2020 volumes (Jan-Feb)

 Ongoing coordination with Napa County Drought Contingency Plan



Staff Recommendation

- Maintain existing allocation policy 11-004
- Allow time for MST/LCWD users to connect
- Allow time for NSH/Stanly Ranch Resort to connect
- Complete Treatment Plant Master Plan to evaluate total supply of summer water
- Continue to coordinate potable reuse through Drought Contingency Plan
