Stephanie Turnipseed, Pollution Prevention and Outreach Specialist, gave a presentation on the PAFR for fiscal year 2020/21. She reported the PAFR contains information from the Annual Comprehensive Financial Report (ACFR) and is designed to make the financial information in the ACFR more understandable for the general public. The report also contains information about work in the treatment plant facility and the community.

Ms. Turnipseed also reported that NapaSan first created their PAFR in 2016 and NapaSan has received the Award of Outstanding Achievement in Popular Financial Reporting by the Government Finance Officers Association (GFOA) for each of the last five years. She indicated that the 2020/21 PAFR incorporated all the suggestions that GFOA made and added elements for ease of reading. The report will be sent out to NapaSan's email contact list, mentioned in NapaSan's Newsletter, highlighted on our Facebook page and posted on NapaSan's website.
