Since you expressed some interest earlier, I thought I'd share Napa County's proposed Small Wind Energy ordinance with you. As you are aware this is being put forward to comply with CA state law (AB 45) and offer some local control over the location an operation of Small Wind Energy Systems within Napa County. The Department will be taking the proposed ordinance to our Planning Commission on Oct 20th. Wind energy systems are already allowed in the areas provided under the proposed ordinance upon the approval of a conditional use permit. The proposed ordinance however offers an administrative (less expensive and less process) permit as well as a use permit option. The proposed ordinance and the supporting environmental document (required under the CEQA) can be found at http://www.countyofnapa.org/SmallWindEnergy/. Public comments are welcome and are due by the 19th or can be provided at the hearing. Please feel free to contact me if you want to more know more about the ordinance, its background locally and in state law, and our desire to implement the ordinance by the end of the year.
