





I am writing in support of Larkmead Vineyards and their request for the increase in production capacity and visitor hospitality at their winery on Larkmead Lane, which is just North of us on Highway 29.

We believe that production increases should be based primarily on total combined contiguous acreage and not just acreage under control of said winery. In Larkmead's case, their total parcels total over 120 acres of contiguous properties on Larkmead Lane. (Currently, Larkmead Lane has only one other winery on the road - Frank Family). The Owners of Larkmead Vineyards are asking for production increases so they would have the capacity to produce all wine grapes from their 111 acres of vineyards. Additionally, increasing visitor traffic as a result of increased production is only logical and beneficial to the Calistoga region of Napa Valley.

It is also important to note the historical significance of the Larkmead Estate to Napa Valley.
