#### 1. CALL TO ORDER

Currently not accepting walk in bill payments. Compost sales also temporarily halted. Received information regarding funding sources from Member Koberstein and have applied for the PPP Application for Payroll and submitted to their company's bank. Business is operating using social distancing. MRF and mixed material currently going to City of Napa facility since unable to practice social distancing at the Whitehall Lane facility. Company will provide more information at the next board meeting on April 20<sup>th</sup>.
