1. CALL TO ORDER

The Upper Valley Waste Management Agency met in special session on Monday, September 20, 2021 at 12:30 p.m. on-site at the Clover Flat Landfill. Chair Mohler called the meeting to order at 12:32 pm then recessed to lunch. Resumed meeting at approximately 12:45 pm.
