Re: Section 18988.1 and Section 18988.4 of SB 1383

Dear Upper Valley Waste Management Agency Member Jurisdictions,

The Department of Resources Recycling and Recovery, Short Lived Climate Pollutions Regulations (SB 1383), Section 18988.1 Jurisdiction Approval of Haulers and Self-Haulers, states that jurisdictions shall require haulers of organic waste to identify the facilities to which they will transport organic waste. Upper Valley Waste Management Agency (UVWMA) has met with Upper Valley Disposal & Recycling (UVD&R) on this topic on behalf of UVWMA member jurisdictions. UVD&R will process organic waste collected from member jurisdictions at both their composting facility on Whitehall Lane (SWIS Number 28-AA-0026) and their composting facility at Clover Flat Landfill (SWIS Number 28-AA-0002). UVD&R will alert UVWMA staff if or when there are any changes to where UVWMA member jurisdictions organic waste will be composted.

Section 18988.4. Recordkeeping Requirements for Compliance with Jurisdiction Hauler Program, requires jurisdictions to keep a record with a description of the jurisdiction's hauler program including:

- (A) Type(s) of hauler system(s) the jurisdiction uses.
- (B) Type(s) and condition(s) of approvals per type of hauler, and criteria for approvals, denials and revocations.
- (C) The process for issuing, revoking, and denying written approvals.
- (D) Any requirements associated with self-hauling and back-hauling.

UVWMA's member jurisdictions use a three-container organic waste collection service, provided by UVD&R. UVWMA's approved organics hauler is UVD&R. The approval of UVD&R to haul organics for UVWMA member jurisdictions coincides with the agreement UVWMA holds with UVD&R to provide solid waste collection services for UVWMA member jurisdictions, with a current agreement end date of June 30, 2036. Any revocation or denial of UVD&R to haul organics will coincide with any decisions made by the UVWMA Board of Directors. Any self-haulers within UVWMA's member jurisdictions are required to source separate organic materials and haul to compost facility. Clover Flat Resource Recovery Park is a permitted self-haul composting location. UVD&R is not permitted for public self-haul.

This memo documents UVWMA's compliance with the subject requirements on behalf of its members.
