A. RICHARD BRUNO - GREENWOOD MANSION/VINUM CELLARS PROJECT - AIRPORT LAND USE CONSISTENCY DETERMINATION #P20-00096-ALUC

Request: Airport Land Use Compatibility Consistency Determination for the proposed Greenwood Mansion/Vinum Cellars Specific Plan Amendment which would allow for the development of a café, tasting room, and office space within the existing Greenwood Mansion as well as an outdoor seating area located at 499 Devlin Road (APN 057-200-028).
