These items regardless of their agenda assigned number will be acted upon by the Commission in one motion at the beginning of the meeting. Applicants having items so listed need not speak unless they disagree with the staff recommendation or wish to comment. If an Item requires discussion, it will be heard in the numerical order listed on the agenda.

State law also requires any participant in a proceeding to disclose on the record any such contributions to an agency officer.

A. PAUL CAMPBELL / POWERSCREEN FACILITY - AIRPORT LAND USE CONSISTENCY DETERMINATION # P08-00382-ALUC

REQUEST: Airport land use consistency determination for a two-story, approximately 17,144 square feet sales, workshop and office building. The project is located on an approximately 2.4 acre site on the west side of State Highway 29, approximately 880 feet north of the intersection with Green Island Road, within Airport Land Use Compatibility Zone D (Assessor's Parcel # 057-130-032).
