SUBJECT: Approval of renewal of Agreements Numbers: 4760; 1992 and 3307

RECOMMENDATION

Agricultural Commissioner/Sealer of Weights and Measures requests approval of and authorization for the Chair to sign renewals of the following revenue agreements with the California Department of Food and Agriculture and the Department of Pesticide Regulation:

- 1. Agreement No. 4760 for a maximum of \$27,546 for the term July 1, 2006 through June 30, 2007 for reimbursement of expenditures for activities related to the sudden oak death inspections;
- 2. Agreement No. 1992 for a maximum of \$500 for the term July 1, 2006 through June 30, 2007 for reimbursement of expenditures for activities related to nursery inspections; and
- 3. Agreement No. 3307 for a maximum of \$10,968 for the term July 1, 2006 through June 30, 2007 for reimbursement of expenditures for activities related with the submission of Pesticide Use Data

EXECUTIVE SUMMARY

Agricultural Commissioner/Sealer of Weights and Measures requests approval of Standard Agreements 4760 and 1992 with California Department of Food and Agriculture (CDFA) and Standard Agreement 3307 with Department of Pesticide Regulation (DPR) for reimbursement of services provided from July 1, 2006 through June 30, 2006.

ENVIRONMENTAL IMPACT

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

BACKGROUND AND DISCUSSION

- 1. Agreement No. 4760 provides for the reimbursement of costs associated with the activities to control the movement of the Oak Mortality disease, such as: Issuing and monitoring compliance agreements with affected parites, inspections and other activities necessary for a nursery to ship plants out of infested areas and regulatory actions to ensure compliance with the regulations. This agreement allocates \$27,546 to perform these activities as required.
- 2. Agreement No. 1992 provides for the reimbursement of costs associated with the performance of nursery inspections in Napa County. This agreement allocates \$500 to perform these inspections as required.
- 3. Agreement No. 3307 provides for the reimbursement of costs relating to the electronic submission of pesticide use data to the Department of Pesticide Regulation. This agreement allocates \$10,968 to perform these activities as required.
