SUBJECT: Napa Communities Firewise Agreement

RECOMMENDATION

County Fire Chief requests approval of and authorization for the Chair to sign an agreement with Napa Communities Firewise Foundation for a maximum of \$100,000 for the term October 15, 2019 through June 30, 2020 for community outreach and assistance in the creation and continuation of Fire Safe Communities and Councils to mitigate the effects of and to survive wildland fires.

EXECUTIVE SUMMARY

The Fire Fund will provide funding for Napa Communities Firewise Foundation for FY 2019-2020. Napa Communities Firewise Foundation is a community-based fire awareness program designed by city, county and state fire professionals to provide the residents of Napa County with: 1) information on the dangers that wildland fire poses to them and their communities; 2) a better understanding of fire ecology in their community in ways that predict the risk while respecting and considering the natural evolution of fire in the wildland settings and; 3) the program provides specific steps each person can take to protect themselves, their family and neighbors in the event of a wildfire. Napa County Firewise was previously funded by grants that have lapsed.

BACKGROUND AND DISCUSSION

As directed by the Board, the Fire Fund will provide funding for Napa Communities Firewise Foundation for FY 2019/2020. The Napa Communities Firewise Foundation is a community-based fire awareness program designed by city, county and state fire professionals to provide the residents of Napa County with: 1) information on the dangers that wildland fire poses to them and their communities; 2) a better understanding of fire ecology in their community in ways that predict the risk while respecting and considering the natural evolution of fire in the wildland settings and; 3) the program provides specific steps each person can take to protect themselves, their family and neighbors in the event of a wildfire. The Napa Communities Firewise Foundation was previously funded by grants that have lapsed. In FY 2011/2012 the Board directed the County Fire Fund to provide funding for the Napa Communities Firewise Foundation. Napa Communities Firewise Foundation continues to seek grant opportunities but available funding is limited.

Under this agreement, Napa Communities Firewise Foundation will provide:

- Support and Outreach to form community based Fire Safety Councils
- Defensible Space Inspections and Evaluations
- Create community maps to identify areas of concerns
- Assistance with mitigation projects
- Assistance in the development of Community Wildfire Protection Plans
- Assistance throughout the Firewise Certification process
- Technical assistance on the implementation of the Community Wildfire Protection Plans
- Host Home Ignition Zone Workshops and Community Meetings
- Maintain a Firewise Website for Napa County

In addition to the \$100,000 designated to the Napa Communities Firewise Foundation, the County Fire Fund will

also continue to support the chipping program to clear land and create defensible space. The additional funding through the County Fire Fund, totaling \$160,000, is included in the 19/20 FY budget to support salaries for the Chipping Crew Bosses of the inmate chipping crews.

The effective date reflects dates of services provided prior to the agreement being in place. Administrative delays have caused the agreement to be brought to the Board late.
