## **RECOMMENDATION**

County Executive Officer requests Board receive a brief update on the progress of the data collection efforts and a preliminary review of themes being heard for the Strategic Plan from Dr. B.J. Bischoff and staff.

### EXECUTIVE SUMMARY

Since contracting with Dr. B.J. Bischoff, Napa County has conducted 5 District meetings and 30 issue focused meetings, and received 2712 survey responses from the public and staff. Dr. Bischoff and staff will provide a brief, preliminary summary of the themes that were consistent throughout these outreach efforts. Following this meeting, the consultant and staff will continue to analyze the data and draft the draft Strategic Plan for adoption on December 18.

### BACKGROUND AND DISCUSSION

The County realizes that a Strategic Plan is an important an effective tool to provide direction and outline measurable goals for the organization and the community. The County has partnered with Dr. B.J. Bischoff of Bischoff Performance Improvement Consulting to work with County staff and the Board to facilitate the development of a Strategic Plan for Napa County, and guide the adoption and integration of the strategic plan throughout the organization. In addition to establishing the priorities for the next three years, the Strategic Plan will establishes a path forward for making informed decisions to meet the current and future needs of the County of Napa's residents, businesses, and visitors. This meeting is the second public meeting related to the Strategic Planning process, and will serve as an update to the Board to share the data collection efforts and findings over the last two months. Members of the Board are invited to provide direction to Dr. Bischoff, the Strategic Planning Taskforce, and staff on the next steps of the process.
