SUBJECT: OnSite Training Agreement with IS Inc. dba Innovative Solutions

### **RECOMMENDATION**

Chief Information Officer requests approval of and authorization for the Chair to sign an agreement with IS Inc. dba Innovative Solutions, for a maximum of \$6,370 for the term October 17, 2006 through June 30, 2007 for software training.

## **EXECUTIVE SUMMARY**

The proposed agreement is for IS Inc. dba Innovative Solutions to conduct software training at a County facility for County employees.

## **BACKGROUND AND DISCUSSION**

The proposed agreement with IS Inc. doing business as Innovative Solutions will provide employees with a two day software training course entitled:

Microsoft Course 2071 – Querying SQL Server 2000

SQL stands for Structured Query Language. It is the language that is used to query databases and is essential for interacting with data stored in an SQL Server. This training is needed to increase County employees' technical job skills; it is a key skill for data analysis, web development and GIS.

IS Inc. will provide a Microsoft Certified trainer to teach the course on site to approximately 12 students. Conducting the training on site was preferable to the more costly off site option.

IS Inc. was chosen as the preferred training company because of their expertise in the field and because of their successful training history with the County. IS Inc. provides in depth, hands-on training on a wide variety of topics. Their depth of skill is evidenced by their unique status as a Microsoft Gold Managed Partner and a Novell Gold Partner. The County has used IS Inc. numerous times since 2000 for individual training classes.
