# RECOMMENDATION

Acting Human Resources Director requests adoption of a resolution regarding the following in connection with Public Works-Engineering, effective October 18, 2005:

- Amend the Departmental Allocation List to delete one (1) (M) Senior Flood Project Analyst and add one (1) (M) Watershed and Flood Control Operations Manager;
- 2. Amend the Table and Index to delete Senior Flood Project Analyst and add Watershed and Flood Control Operations Manager; and
- 3. Amend appropriate policies to delete Senior Flood Project Analyst and add Watershed and Flood Control Operations Manager.

### EXECUTIVE SUMMARY

The Public Works Department needs to start moving forward to ensure an effective transition from a flood control/water quality program that has had a primary focus on the delivery of capital improvements to a flood control/water quality program that focuses on the maintenance of these projects. Approval of the requested actions will provide for that transition.

# BACKGROUND AND DISCUSSION

The Public Works Department needs to start moving forward to ensure an effective transition from a flood control/water quality program that has had a primary focus on the delivery of capital improvements to a flood control/water quality program that focuses on the maintenance of these projects. The proposed action to delete the vacant Senior Flood Project Analyst position and replace it with the Watershed and Flood Control Operations Manager will provide a key transitional position to oversee watershed operations in the post-construction period of the Flood Project. This position will focus on the science of monitoring and recommending appropriate maintenance responses to ensure that the capital improvements do provide the flood protection anticipated. This position would also assume certain responsibilities of the Principal Public Works Engineer and Flood Project Manager when these positions are vacated. The position will also continue to serve as the liaison for other Measure "A" projects where the County has partnered with other interests to provide flood protection and water quality enhancements (for example, Rutherford Dust Society).

Acting Human Resources Director is recommending the salary for the Watershed and Flood Control Operations Manager be set at the same range as the Principal Public Works Engineer based on the level of responsibility, education, and experience requirements.
