SUBJECT: Amendment No. 1 to Agreement No. 6713 with NewPoint Group, Inc.

RECOMMENDATION

County Executive Officer requests approval of and authorization for the Chair to sign Amendment No. 1 to Agreement No. 6713 with NewPoint Group, Inc. increasing the amount by \$85,000 for a new maximum of \$184,900 for the term May 1, 2006 through June 30, 2008 to conduct a review of the final accounting records of Waste Management Inc.

EXECUTIVE SUMMARY

NewPoint Group, Inc. has conducted a review and analysis within the scope of the existing Agreement No. 6713 of the final accounting records of former Zone 1 solid waste franchisee Waste Management, Inc., a subsidiary of Napa Valley Disposal Service. The amendment and revised scope of services will allow further analysis and preparation for possible litigation. The new term of the agreement will expire on June 30, 2008.

ENVIRONMENTAL IMPACT

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

BACKGROUND AND DISCUSSION

County staff is reviewing the final accounting for Waste Management Inc., a subsidiary of Napa Valley Disposal Services, Inc., for the Zone 1 franchise agreement that expired on September 30, 2005. In reviewing the final accounting records submitted by Waste Management Inc. as required by Agreement No. 4717, the decision was made to contract with an independent accountant to fully evaluate the accuracy of the documents. The County contracted with NewPoint Group, Inc. to conduct a review of the final accounting records of Waste Management Inc. within the scope outlined in Agreement No. AUD 5839 which was superseded with Agreement No. 6713. County staff have determined that the scope of services requires to be expanded to accommodate further analysis and potential future litigation. To complete the analysis, the amount of the new agreement will be for a new maximum amount of \$184,900. The new agreement will replace and supersede the previous Agreement No. AUD 5839 and current Agreement No. 6713, entered into on October 17, 2006.
