**SUBJECT:** Approval and renewal of Agreements Numbers: 4168 and 3307.

## RECOMMENDATION

Agricultural Commissioner/Sealer of Weights and Measures requests approval of and authorization for the Chair to sign renewals of the following agreements for the term July 1, 2005 through June 30, 2006:

- Agreement No. 4168 with the California Department of Food and Agriculture for a maximum of \$77,740 for reimbursement of expenditures for activities related to the Olive Fruit Fly Trapping and Pest Detection Trapping services; and
- Agreement No. 3307 with the Department of Pesticide Regulation for a maximum of \$9,928 for reimbursement of expenditures associated with submission of Pesticide Use Data to the Department of Pesticide Regulation.

# **ENVIRONMENTAL IMPACT**

# **BACKGROUND AND DISCUSSION**

- 1. Agreement No. 4168 provides for the reimbursement of costs associated with insect detection trapping in Napa County for Olive Fruit Fly, Mediterranean, Oriental and Melon fruit flies, Gypsy Moth and Japanese beetles. This agreement allocates \$77,740 to perform these activities as required.
- 2. Agreement No. 3307 provides for the reimbursement of costs relating to electronic submission of pesticide use data to the Department of Pesticide Regulation. This agreement allocates \$9,928 to perform these activities as required. Administrative delays at the state and local level resulted in these contracts not being submitted for Board approval until now.
