SUBJECT: Registrar of Voters requests Board declare elected those persons and results of those measures under its jurisdiction based on the certified results of the November 8, 2016 General Election

RECOMMENDATION

Assessor-Recorder-County Clerk in his capacity as ex-officio Registrar of Voters requests that the Board:

1. Declare elected those persons, under its jurisdiction, based on the certified results of the General Election held on Tuesday, November 8, 2016; and
2. Declare the results of countywide measures under its jurisdiction based on those same certified results and by declaring Measure A as having passed, the Board is ratifying the approval of Ordinance 2016-03 by the voters of Napa County.

EXECUTIVE SUMMARY

Elections Code Section 15372 provides that the elections official shall prepare a certified statement of the results of the General Election held on November 8, 2016, and submit it to the governing body within 30 days of the election. The Assessor-Recorder-County Clerk, in his capacity as ex-officio Registrar of Voters, sent the certified statement to the Board of Supervisors on December 5, 2016 within the 30 day period. In addition, Elections Code Section 15400 provides that the governing body (Board of Supervisors) shall declare elected those persons under its jurisdiction and declare the results of countywide measures based on those certified results. The list of persons elected and results of measures is attached. Measure Z failed because it did not achieve a 2/3 majority. Measure B failed because it conflicted with Measure A and passed with fewer yes votes than Measure A.

BACKGROUND AND DISCUSSION

The Registrar of Voters has also sent certified results to the municipal and school district governing bodies who in turn declare the results of the elections for elected candidates to their respective councils and boards of trustees as well as any measures.
