# BACKGROUND AND DISCUSSION

The County's Memorandum of Understanding provides a list of observed holidays. The following no meeting dates are due to County observed holidays.

January 2, 2007 (due to New Year's Day)
January 16, 2007 (due to Martin Luther King, Jr. Day)
February 13, 2007\* (due to Lincoln's Birthday)
February 20, 2007\* (due to President's Day)
May 29, 2007 (due to Memorial Day)
July 3, 2007 (due to Independence Day)
September 4, 2007 (due to Labor Day)
November 13, 2007 (due to Veteran's Day)
December 25, 2007 (due to Christmas Day)

There is no meeting on October 30, 2007 because it is the fifth Tuesday of the Month.

Budget Hearings for Fiscal Year 2007-2008 are scheduled to be held June 18 through June 20, 2007. Final Budget adoption is scheduled for June 26, 2007. A 4/5 vote is required for final budget adoption.

The Board Retreat is tentatively scheduled for April 9 and April 10, 2007. The afternoon agenda for the April 10 meeting is reserved for Consent Calendar and Closed Session items.

Joint meetings with the Napa City Council are held quarterly and are tentatively scheduled for January 30, April 24, July 24 and October 23, 2007.

Approval of the Special District calendars for 2007 will take place at the first meeting of the year, January 9, 2007.
