RECOMMENDATION

Director of Public Works requests approval of and authorization for the Chairman to sign Amendment No.1 to an agreement (formerly AUD 8086) with Garcia and Associates to formally incorporate California Department of Transportation (Caltrans) Local Assistance Procedures Manual provisions for the Oakville Bridge Replacement Project, RDS 05-05 in Napa County.

EXECUTIVE SUMMARY

On March 18, 2014, the Board of Supervisors awarded Agreement No. 8086 in the amount of \$230,025 to Garcia and Associates of San Anselmo, California to implement the Cultural Resources Data Recovery Plan for the Oakville Cross Road Bridge Replacement Project, RDS 05-05. The Request for Qualifications stipulated that the Oakville Cross Road Bridge Replacement Project is funded by the FHWA HBBR (Highway Bridge Replacement) program. This amendment clarifies that this project is funded by FHWA funds and formally incorporates California Department of Transportation (Caltrans) Local Assistance Procedures Manual provisions.

ENVIRONMENTAL IMPACT

BACKGROUND AND DISCUSSION

In order to implement the Cultural Resources Data Recovery Plan for the Oakville Cross Road Bridge Replacement Project, RDS 05-05, the Public Works Department released a Request for Qualifications (RFQ) inviting consulting archaeological firms to provide Section 106 of the National Historic Preservation Act coordination, including data recovery and construction monitoring services in connection with the subject project. The Request for Qualifications stipulated that the Oakville Cross Road Bridge Replacement Project is funded by the FHWA HBBR (Highway Bridge Replacement) program.

On March 18, 2014, The Napa County Board of Supervisors awarded Agreement No. 8086 in the amount of \$230,025 to Garcia and Associates of San Anselmo, California to implement the Cultural Resources Data Recovery Plan for the Oakville Cross Road Bridge Replacement Project, RDS 05-05. This amendment clarifies that this project is funded by FHWA funds and formally incorporates California Department of Transportation (Caltrans) Local Assistance Procedures Manual provisions.

This amendment does not change the agreement amount of \$230,025.
